public procurement of goods-coal for heating season 2017/2018

1. Name, address and internet page of the Contracting authority: Public Utility Company „Toplana“ Bor, St.Đ.A.Kuna No. 12. Bor, www.toplana.rs;
2. Type of the Contracting authority: public company founded by local authority;
3. Type of public procurement: open procedure;
4. Description of the procurement subject: procurement of goods – coal for heating season 2017/2018; Dark coal separated washed (SP), granulation 5-15 mm - 10.000 t , 5-20 mm - 22.500 t , and 5-30 mm – 4.000 t , and lignite dried, granulation 5-60 mm 4.500 t ;
Total quantity 41.000 t .
Name and index from common procurement vocabulary: ORN – coal 09111100 and lignite 09112100;
5. Subject of the public procurement is not organized by lots;
6. Criterion for awarding a contract is the lowest offered price;
7. Tender documentation can be downloaded form the Public Procurement Office Portal, and web page of the Contracting authority www.toplana.rs
8. Manner of submitting bids: bidder submits the bid in person or via mail in closed envelope or a box. Bid is to be submitted to the following address: Public Utility Company „Toplana“ Bor, St. Đ. A. Kuna No. 12, 19210 Bor, or in person to the secretary of the director in the administrative building of Public Utility Company „Toplana“ Bor in the RTB-Bor zone with a note: „Bid for public procurement of goods – Coal for heating season 2017/2018, No. JNVV 08/2017 – DO NOT OPEN“.
Deadline: bid shall be deemed timely if it is received by the contracting authority on 13.09.2017. at 12:00h.
9. Place, time and manner of opening bids: opening of bids is public and it will be organized immediately after the expiration of deadline on 13.09.2017. at 12:30h in the administrative building of the contracting authority which is located in the RTB zone with members of the commission for the public procurement in question;
10. Conditions for bidders' representatives to participate in the opening bids procedure: Bidders' representatives must submit to the Commission an authorization for bidders' representatives which will participate in the opening bid procedure before the opening begins (Form in chapter XVII of tender documentation) or certificate from Business Registry Agency when legal representative of owner is present at the opening procedure. Bidders who personally deliver the bid or intend to participate in the opening procedure must announce their arrival one day in advance due to a entering procedure in the RTB-Bor zone;

11. Decision deadline: decision for awarding a contract will be made in legal deadline of 25 days from the opening procedure;
